The **German Society for Biochemistry and Molecular Biology (GBM e.V.)** is the largest life science society in Germany with about 5,000 members from biochemistry, biology, chemistry, physics, pharmacy and medicine.

Renowned conferences with top speakers (**Mosbacher Kolloquium; GBM Fall Conference**) are a signature of the GBM.

The GBM has also actively developed into a gathering place for researchers from the field of applied research and industry.
